## Somerset Cricket Board updates

As we continue to adhere to Government guidelines and help to play our part in combating the spread of Coronavirus, we have reverted to reduced operations. The impact that this will place on our services is as follows:

- **Upcoming events:** All Somerset Cricket Board courses and related cricket activity is currently suspended until further notice.
- **Somerset Cricket Board offices:** The Somerset Cricket Board office will be closed to the public until further notice. We are still contactable by telephone or email, although our response times may be slower than usual due to remote working practices.

As you may have read, the recreational cricket season has been postponed until further notice. We must stress that all dates are fluid and subject to change dependent on this evolving situation. We will continue to evaluate these working practices and timescales on a weekly basis.

We will continue to support our clubs and communities. Based on the feedback you gave us we will be focussing on three main areas:

### 1. People

- Players – Communicate ideas and activities to keep players engaged with cricket and developing their skills.
- General membership – Encourage and support clubs to engage with their general membership and continue to bring people and communities together (remotely of course)

### 2. Finance – Communicate regularly about funding pots, ways to cover fixed costs and reduce general outgoings.

### 3. Facilities – In particular maintenance of grounds and squares. Collate and distribute latest information and guidance for clubs and groundskeepers.

With the above in mind this document has been created to help provide the most up to date info on Covid-19 and the three focus areas for us. The situation with Covid-19 is fast-moving, so clubs should check key sources of info including Government, ECB & Sport England.

**Note to clubs:** We are operating in unprecedented times and the information within this document, while accurate to the best of our knowledge, may contain details that are no longer 'current'. ## Finance

With no date for recreational cricket to restart there are lots of club who have concerns over the about the potential financial impact of Covid-19. Whilst there are some savings clubs can make whilst cricket is suspended (detailed in the Facilities section), the lost revenue from membership subscriptions, match fees and social activity is a very live concern.

Below we have attempted to summarise the schemes available at present which clubs should investigate:

### Government support

All clubs should look to explore the support for businesses which the Government have put in place due to Covid-19. Cricket falls within the 'leisure' or (for some of bigger clubs) the 'hospitality' sector and as such you may be eligible for support under one or more of the following schemes:

1. **Cash grants for retail/hospitality/leisure sector** - The Small Business Grant Fund (and the Retail, Hospitality and Leisure Grant could provide clubs with grants of between £10,000 and £25,000 depending on the rateable value of your property and your current business rates arrangement with the local authority.

2. **Business Interruption Loan Scheme** - Supports small and medium-sized businesses to access loans, overdrafts and other financial support.

3. **Business Rates Holiday** - Businesses in the retail, hospitality and leisure sectors in England will not have to pay business rates for the 2020 to 2021 tax year. 4. **Deferral of VAT payments** – The government has announced temporary changes to the VAT payments due between March 20th and June 30th to help businesses manage their cash flow. See <https://www.gov.uk/guidance/deferral-of-vat-payments-due-to-coronavirus-covid-19>

#### (ONLINE) Level 1 Cricket Grounds Maintenance

The Grounds Management Association (GMA) have a range of training courses that are suitable for the professional to the grass roots volunteer and have launched a new online Level 1 module on Cricket Grounds Maintenance to allow you to gain an awareness and general understanding of the tasks involved in maintaining playing surfaces.

#### What does the course content cover?

There are 3 modules to this training course. All are designed to either give you a new understanding or build on your experiences so far.

- Requirements of the groundsperson and pitch
- Maintenance activities (Equipment and Machinery)
- Safe use and storage (Materials)

Each module has an informal self-assessment test, plus there is a formal end of course multiple choice assessment test, which is also online.

After you have completed these 3 modules, we will also suggest other topics of progression should you wish to continue to learn.

## ECB guidelines for the use of outdoor cricket facilities- Updated 5<sup>th</sup> June

Read below for the ECB guidance for cricket clubs relating to opening of nets and outfielders for physical activity which includes details on 6 people training or being coached (1 Coach- 5 People)

Please note, this guidance is provided to support the advice of government and medical experts, as well as to offer practical guidance to players and clubs on the steps they should take to remain safe whilst undertaking exercise in an outdoor cricket club environment. **Equally, no club should reopen their outdoor facilities if they feel unable to meet the requirements.**

Please read the advice document carefully before opening your club facilities should you wish to or making changes to your current opening operations, and we urge players and parents to be patience with clubs whilst they work out if they can open facilities or make changes.

## Managing Vacant Buildings and Operating Safely – A Guide for Recreational Cricket Clubs

### Managing temporarily closed / unoccupied buildings

Temporarily closed or permanently unoccupied buildings can be at greater risk from arson, antisocial behaviour, theft, and escape of water. ECB-appointed broker Howden have provided some advice and solutions to manage this increased risk.

### Short term savings and utilities

Whilst your clubhouse isn't being used there is the opportunity to save money by turning off gas, water, heating – especially if the club is shutting for a prolonged period. It is also worth exploring if it is possible for your club to pause payments with agreement of your supplier?

If you have a bar contact your supplier as we are aware of breweries offering to replace any stock which goes out of date during this time.

Contact your insurers to discuss whether your current policy is appropriate during this period. Can payments be delayed or deferred? Does the policy cover 'loss of earnings'?
